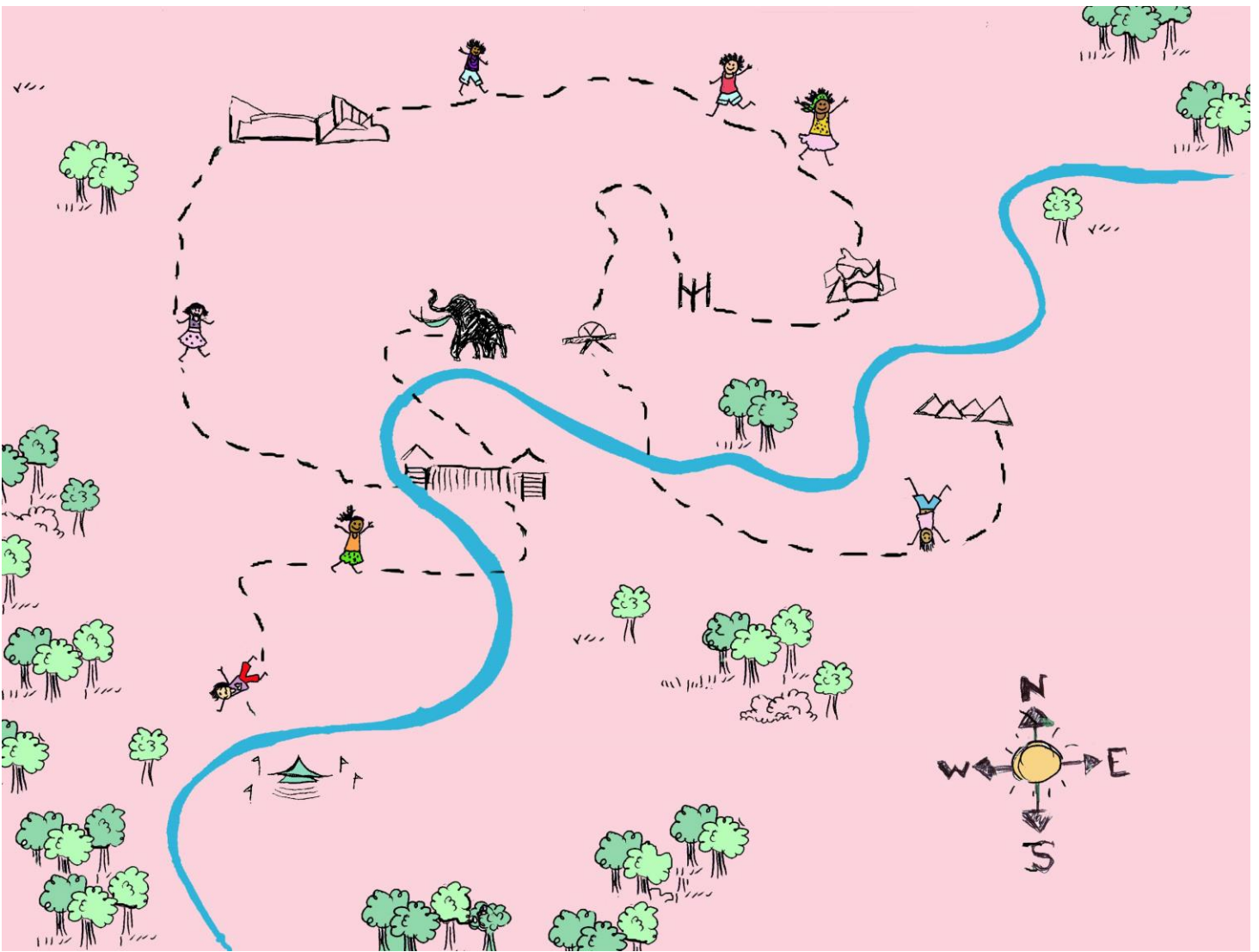

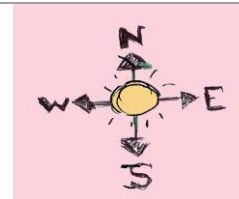

- We understand that your child must be signed in (by a parent/guardian) at **8:30am** at the starting point of Art Adventures classes which is the Alex Taylor building, and signed out and picked up at **4:30pm** from the Alex Taylor building.
- We understand that if an Art Adventures class is cancelled, we will be notified and will not come that day.
- We understand that Art Adventures instructors are volunteers and staff who have been screened and interviewed and will provide us with the best instruction that they can. We agree to honor and respect their time and commitment.
- We understand that Art Adventures is not a drop-in program. Students must attend all classes, unless an unforeseen situation arises, such as illness.
- We understand that if we are going to miss a group class we must phone or email at least 6 hours in advance. We also understand that failure to do so may result in our removal from the program.
- We understand that if we do not request and pay \$50 for 8 lunches it is our (parent/guardian/student) responsibility to bring a proper lunch to program.
- We understand that everyone at Art Adventures will be treated with dignity and respect at all times. Swearing and insults will not be tolerated by anyone.
- We understand that Art Adventures only provides supervision for students only when they are in program between sign-in (8:30am) and sign-out (4:30pm) times.
- We understand that the **majority of communication to parents is done via email**, and it is our responsibility to check our emails frequently.
- We understand that by not following this contract, we may be removed from Art Adventures.

Field trip indemnity and release of liability form

I understand that E4C Art Adventures is a program where my child will be visiting a variety of locations throughout Edmonton. Some examples of these sites include The Art Gallery of Alberta, SNAP Gallery, Fort Edmonton Park, Heritage days, Muttart Conservatory, Telus World of Science, Royal Alberta Museum on Thursday, Heritage days, Harcourt house and local parks. I agree to allow my child to ride Edmonton's city bus/LRT as this will be the mode of transportation Art Adventures will use to get to the various locations.

I agree to save and hold harmless and indemnify E4C Art Adventures from and against all lawsuits, claims, actions, cost or expenses in respect to any death, injury, loss, damage to my child or my child's property howsoever caused arising out of or in connection with the events and whether the same may have been contributed to or occasioned by the negligence of E4c Art Adventures.
